## Scholarship Guidelines

Dubuque Montessori is able to offer a limited number of scholarships based on income levels and family needs. The number of scholarships is dependent on available funds.

Applications are accepted year-round and if selected, a most recent tax return must be submitted for verification.

- This scholarship is need-based. Based on income, families will receive at least 50% of tuition reduced.
- Scholarship is awarded as a tuition reduction, not as a cash receipt.
- DMS will publicize the availability of the scholarship. The number of scholarships awarded each year is dependent on available funds.
- A committee will review all scholarship applications and will present those of greatest need to the Co-Directors for approval.
- If selected as a recipient you will receive a letter stating the awarded financial support at which point **a most recent tax return must be submitted for verification.**
- All recipients must re-apply each year.
- This scholarship is solely for tuition assistance. It does not include the registration fee, supply fees, or extended care.
- Extended care assistance is available through the Department of Human Services. Please call 866-448-4605 for more information.
