ADDITIONAL INFORMATION

- Scholarship applications are accepted year-round; however, distribution of available funding is anticipated to happen at the start of the school year.
- Scholarships will be awarded as payments toward tuition and be spread equally over the 10 months of the school year, or remaining months for scholarships awarded mid-year.
- DMS will publicize the availability of the scholarship. The number of scholarships and amounts awarded each year is dependent on available funds. Amounts will be between 25% and 100% tuition based on need and available funds.
- The current year scholarship application must be filled out entirely. **If selected as a recipient, the most recent tax return must be submitted for verification.**
- All scholarship applications and recipient information are kept confidential.
- If a scholarship applicant qualifies for a Dubuque County Early Childhood (DCEC) preschool scholarship, they will not qualify for a DMS scholarship. Please inquire with Director for DCEC info.
- The scholarship recipient's attendance will be regularly reviewed. Absences and/or tardiness deemed excessive may result in loss of the scholarship. It is at the discretion of the Director to approve absences and/or tardiness from extenuating circumstances.
- Failure to follow the DMS Parent Handbook guidelines and the DMS Parent/School Agreement Contract may result in loss of the scholarship.
- All recipients must reapply each year.
- The scholarship is solely for tuition assistance. Registration fees, extended care, or any other fees must be paid separately. Extended care payment assistance is available through the Iowa Department of Health and Human Services.

Applications and supporting documentation will be reviewed in the order received and scholarships are awarded with priority given in the following order:

- Returning families with the greatest financial need.
- New families with the greatest financial need.
- Returning families that meet income guidelines for the DCEC scholarship but do not qualify due to age of child and/or lack of Iowa residency.
- New families that meet income guidelines for the DCEC scholarship but do not qualify due to age of child and/or lack of Iowa residency.
- Scholarship assistance may be given to families outside of the income guidelines only after all income-eligible applicant families have been awarded scholarships and the circumstance of scholarship need is unique.

Appeals regarding scholarship funding may be brought to the DMS Board Co-Presidents.
